

WHILE OPEN FOR THE FULL YEAR, THERE WERE SEVERAL COVID RELATED CLOSURES, STAFFING CHALLENGES, AND TRANSPORTATION CHALLENGES.

WITH THE COVID-19 PANDEMIC, PROGRAM SERVICES SHIFTED PRIMARILY TO REMOTE OFFERINGS IN MARCH 2020 AND THIS CONTINUED THROUGH THE FIRST HALF OF FY22.

VILLAGE EVENT ATTENDANCE TOTALED 4,679 FOR THE YEAR, WITH A MIX OF REMOTE AND OUTSIDE, SOCIALLY DISTANCED ACTIVITIES. MEMBERS HAVE BEEN EXCITED TO GET BACK TO IN-PERSON EVENTS.
